## SECTION 4. FIRST-AID MEASURES

### First-aid Measures

#### Inhalation

Move to fresh air. Get medical advice or attention if you feel unwell or are concerned.

#### Skin Contact

### Extinguishing Media

#### Suitable Extinguishing Media

Not combustible. Use extinguishing agent suitable for surrounding fire.

### Specific Hazards Arising from the Product

May include but is not limited to: corrosive phosphorous oxides; very toxic carbon monoxide, carbon dioxide.

### Special Protective Equipment and Precautions for Fire-fighters

Do not use water jet as an extinguisher, as this will spread the fire.

A full-body encapsulating chemical protective suit with positive pressure SCBA may be necessary.

## SECTION 6. ACCIDENTAL RELEASE MEASURES

### Personal Precautions, Protective Equipment, and Emergency Procedures

Evacuate the area immediately. Isolate the hazard area. Keep out unnecessary and unprotected personnel. Do not touch damaged containers or spilled product unless wearing appropriate protective equipment.

### Environmental Precautions

It is good practice to prevent releases into the environment.

### Methods and Materials for Containment and Cleaning Up

Stop or reduce leak if safe to do so. Contain and soak up spill with absorbent that does not react with spilled product. Place used absorbent into suitable, covered, labelled containers for disposal.

### Precautions for Safe Handling

Do not get in eyes. Only use where there is adequate ventilation. Avoid generating vapours or mists. Wear personal protective equipment to avoid direct contact with this chemical. Wash hands thoroughly after handling this material.
