### 4. FIRST AID MEASURES

<b>Inhalation:</b>	Remove to fresh air. If symptoms persist consult physician.
<b>Eye Contact:</b>	Remove contacts. Flush with water for at least 20 minutes, occasionally lifting the upper and lower eyelids. Get medical attention immediately.
<b>Skin Contact:</b>	Thoroughly wash exposed skin with soap and water. Remove any contaminated clothing and wash before reuse.
<b>Ingestion:</b>	Wash out mouth with water. Drink plenty of water. Do not induce vomiting unless directed by medical personal. Never give anything to an unconscious person. Get medical aid.
<b>Notes to Physician:</b>	Treatment based on judgment of attending physician. Hydrogen peroxide at these concentrations is a strong oxidant. Direct contact with the eye is likely to cause corneal damage especially if not washed immediately. Careful ophthalmologic evaluation is recommended and the possibility of local corticosteroid therapy should be considered. Because of the likelihood of corrosive effects on the gastrointestinal tract after ingestion, and the unlikelihood of systemic effects, attempts at evacuating the stomach via emesis induction or gastric lavage should be avoided. There is a remote possibility, however, that a nasogastric or orogastric tube may be required for the reduction of severe distension due to gas formation.

### 5. FIRE FIGHTING MEASURES

<b>Suitable extinguishing media:</b>	Flood with water for extinguishing agent. CO2 may provide limited control.
<b>Unsuitable extinguishing media:</b>	Do not use dry chemicals or foams.
<b>Special exposure hazards</b>	Oxidizing substances can be decomposed by water and direct sources of heat. Decomposition releases oxygen which can support combustion.
